Regarding issue of No Objection Certificate for the introduction of B.E. Courses. on Self Financing Scheme basis, on regular basis.

Madam'

I am directed to refer to your letter No. EDN-II(8)Pvt B.Ed./2005, dat 13.12.2005 on the subject cited above and to convey the approval of the Government with regard to issue of "No Objection Certificate" in respect of College of Advance Study in Education, Kheri Road, Rajgadh, Distt. Sirmour, H.P. managed by Shri Shal Vidyapeeth Society, Village & Post Office Deedag, Tehsil Rajgadh, Distt Sirmour, for the introduction of B.Ed. Courses, on regular basis, with an annual intake of 10 students, from the Academic Session 2006-2007, subject to prior recognition of the "National Council for Teacher Education. The distribution of seats shall be as per the details given below:-

1. Arts	40 seats
2. Medical	30 seats
3. Non-Med.	30 seats
Total:	100 seats

This "NOC" for the introduction of B.Ed. Courses in respect of above named College/Trust is being issued subject to the following conditions:-

1. that Society/Trust should be owner in possession of land.
2. that 50% of the seats will be free seats and 50% will be paid seats as per rules framed by the NCTE/HPU/State Govt.
3. that aforementioned Institution will have to give the reservations to SC/ST/OBC and other reserved categories as per guidelines of the NCTE/HPU/State Government and instructions issued thereof from time to time by the Government.

4. that the fees prescribed will be strictly in accordance with the rates fixed by the "Fee Structure Committee constituted by the Government in accordance with the guidelines of the NCTE/ H. P. University.
5. that above institution will have to fulfill the all codal formalities i.e. Norms and Standards and other conditions laid down by the NCTE/HPU/UGC as well as Norms and Standards notified by the State Government on 20.12.2004.
6. that the State Government will not provide any type of Financial Assistance/Grant-in-Aid etc., in respect of the said Institution.,
7. that the seats reserved for the bonafide candidates of the State are "OPEN SEATS" and the other will be "PAID SEATS" for which the separate fee structure shall be decided by the Fee Structure Committee constituted by the Government from time to time. However, the selection to all seats(Open and Paid Seats) shall be on the basis of "MERIT" as per the marks obtained in the "ENTRANCE TEST" conducted by the H. P. University
8. The validity of "NOC" will be for "Three Years" only.
